2024 Plan of Work Luke Johnson General Manager

Tri-County Electric Cooperative's Board of Directors recently approved the annual plan of work for 2024. Each year, a number of line projects which should improve the reliability of the electric distribution system are selected and prioritized. Some lines are replaced due to age and condition. Other lines will be replaced with a larger conductor due to load growth.

The following are items included in our 2024 plan of work:

- Pole Replacements -Approximately 400 poles will be replaced in 2024. Poles are inspected on an eight-year rotation cycle and poles that fail inspection are replaced. This year, the poles will be inspected and replaced as needed in the entire Ashley, Woodlawn, and Waltonville Substation areas.
- Kinmundy East (Phase 1 of 3) - Upgrade 2.5 miles of aged

three-phase with larger conductor needed to increase reliability and upgrade the line during switching.

- Reserve Northeast Upgrade 2 miles of aged three-phase conductor to enhance reliability and strengthen the tie line.
- Sectionalizing Upgrade regulators, capacitors, and OCR's (oil circuit reclosers).
- •Substation Improvements -Maintenance to help improve reliability will be conducted on various substations. This work should also prolong equipment life and increase efficiency.

The goal of all of the above mentioned system upgrades is to improve service reliability for the membership.

Tri-County Electric Cooperative distributes energy to 16,428 meters across 3,409 miles of energized line over 62,000 poles, averaging 4.82 members per mile of line.

2024 Illinois Electric Cooperative Scholarships

Illinois electric cooperatives will award 16 scholarships in 2024 to financially assist deserving students in the electric cooperative family. The 16 scholarships, \$2,000 each, will be awarded through the Thomas H. Moore Illinois Electric Cooperatives (IEC) Memorial Scholarship Program.

Ten scholarships will be awarded to high school seniors whose parent(s) are an Illinois electric co-op member. In addition, the Earl W. Struck Memorial Scholarship, will be awarded to a student who is the child of an Illinois electric cooperative employee or director. Five additional scholarships are reserved for high school seniors enrolling full time at a two-year Illinois community college

whose parent(s) are an Illinois electric cooperative member, employee or director.

The 16th scholarship, the LaVern and Nola McEntire Lineworker's Scholarship, will help pay for costs to attend lineworker school conducted by the Association of Illinois Electric Cooperatives in conjunction with Lincoln Land Community College, Springfield, IL. Children of co-op members, relatives of co-op employees or directors, and individuals who have served or are serving in the armed forces or National Guard are all eligible for this scholarship.


2024 Forestry Cycle

Asplundh and Nussmeyer Tree Service will begin forestry work in January 2024. The substations in the 2024 program are: Iuka, Hoyleton, Marlow, Jaycee, and Barva.

The Forestry Program is a cycle program developed to trim, remove trees, mow brush, and apply herbicides to each substation area in a four-year cycle.
