This year, we have the pleasure of welcoming guest speaker Chuck Tiemann to share his message. Tiemann is committed to teaching others about electrical safety. He is known worldwide for sharing his own unforgettable - and true - electrical safety story. In 1980, then a lineworker at Kay Electric Cooperative in Blackwell, Oklahoma, Chuck made contact with an energized 7,200-volt power line. As a result of the accident, he died, was brought back to life, and then underwent the amputation of his left arm and right leg. Over the next 41+ years after his accident, Chuck has dedicated his life to sharing those lessons so others wouldn't have to learn them as he did.

TCEC Board of Directors

One of the most valuable principles of the cooperative business model is democratic control. Boards of cooperatives are democratically elected by the membership to govern and direct the affairs of the cooperative.

Tri-County Electric Cooperative has a 9-member board with three directors from each of the primary counties served, Jefferson, Marion, and Washington. The membership elects one director for each district at the annual meeting each year, and the directors serve three-year rotating terms. This year's annual meeting will be held on Saturday, July 13, 2024.

Board candidates can be nominated by petition signed by at least 25 members, and signatures may come from the entire Cooperative membership.

Petitions may be picked up in person, sent to a member by e-mail, or mailed to a member, but must be filed in person. The Credentials and Elections (C&E) Committee will meet to review the qualifications of petitioning nominees and supervise nominations of board members.

If there are no nominations by petition for the district in which a director is to be elected, it is the duty of the C&E Committee to select a nominee(s) for that district. The C&E Committee is scheduled to meet on Monday, April 22nd, 2024, and the members of the committee are: Tonya Lowery, Mark Mitchell, Ralph Hilmes, Keith Doehring, Geff Purcell, & Dennis McClellan.

The U.S. Representatives will meet with students for a luncheon while on Capitol Hill.
