- 3. Optional: Once the cookies have cooled completely, melt the white chocolate in the microwave until smooth and dip half of each cookie in the chocolate. Lay them onto wax paper and immediately add sprinkles while the chocolate is still wet. Let the chocolate harden up and serve!
