One of the most valuable principles of the cooperative business model is democratic control. Boards of cooperatives are democratically elected by the membership to govern and direct the affairs of the cooperative.

Tri-County Electric Cooperative has a 9-member board with three directors from each district. The territory of the cooperative has three districts, each of which contains one of the primary counties (Jefferson, Marion, and Washington) of the Cooperative. The membership elects one director for each district at the annual meeting each year, and the directors serve three-year rotating terms. This year's annual meeting will be held on July 10, 2021.

Board candidates can be nominated by petition signed by at least 25 members, and signatures may come from the entire Cooperative membership. A joint membership constitutes of only one member - meaning if both the member and the joint member sign the petition, it counts as one signature.

Petitions can be picked up as early as February 10, 2021, and filed in person along with an affidavit stating that the person filing the petition meets the qualifications to become or remain a board member. Petitions must be filed in person at our Mt. Vernon office no later than close of business on Monday, April 12th, 2021.

Petitions may be picked up in person, sent to a member by e-mail, or mailed to a member, but must be filed in person. 1 (12 oz.) bag of chocolate chips


2 c nuts (pecans or walnuts)

CONSIDERING SOLAR? CALL US FIRST!

Deciding to purchase solar panels for your home can seem complicated when you are dealing with both a solar company and a utility. At Tri-County Electric Cooperative, we strive to make the transition as easy as possible.

As a member with solar panels installed, Tri-County Electric Cooperative will always be there to back you up when your system is not producing enough energy to power your home. Since there is an interconnection between your system and the cooperative electric distribution system, safety is of utmost importance. If you are considering solar, we ask that you contact the cooperative as soon as possible.

When you contact the cooperative, you can learn more about the policies regarding the ownership and interconnection of a solar unit. At that time, we will also study whether additional equipment and upgrades will be needed.

Our current one-way grid is expected to be all things to all members, but it simply wasn't built for large amounts of two-way power flows.

In locations where solar PV penetration levels are high, specific planning is undertaken and every connection request is carefully considered to take into account current network capacity limitations.

We know that investing in solar energy isn't for everyone, but if you are considering installing a solar photovoltaic system, please include us in your planning process.

Remodel Update

By the time you receive this newsletter, our Billing Department should be moving into their remodeled workspaces! We will have photos in our February newsletter of the final product. Here are a few images of the most recent changes in our building to date.

If all goes according to schedule, you will be visiting us at the 3906 Broadway location very soon. We will be relocating the Engineering, Operations, and Manager's Departments to various portions of the building. The vehicle garage, multipurpose room, and member consult rooms will serve as makeshift office spaces during our second phase of construction.

Remodeling and keeping all workspaces socially distanced during a pandemic has presented its fair share of challenges, but we have all worked together to find creative solutions.

Once the billing department returns to their normal location, our temporary office location at 53 Crownview will undergo asbestos abatement, and be torn down to make room for the new entrance/exit for our line trucks to access the stoplight. At that time, we will also be adding additional parking for employees. The estimated total completion of the project is scheduled for April 2021.



The front entrance of the building is still under construction. We expect to have the masonry complete, lighting, and signage by the end of January.
